### Description of first aid measures

**General information:** Immediately remove any clothing soiled by the product.

Symptoms of poisoning may occur even after several hours; therefore medical observation for at least 48 hours after the incident is recommended.

In case of irregular breathing or respiratory arrest provide artificial respiration.

## 4 – FIRST-AID MEASURES

**After inhalation:** In case of unconsciousness place patient in recovery position and get emergency medical advice. Exposure can cause numbness, tingling and weakness in extremities. The chemical, physical and toxicological properties have not been thoroughly investigated.

**After skin contact:** Immediately wash with water and soap and rinse thoroughly.

**After eye contact:** Rinse opened eye for several minutes under running water. Then consult a doctor.

**After swallowing:**

Rinse mouth. Do not induce vomiting. Call a doctor immediately.

### 5 – FIRE FIGHTING MEASURES

#### **Extinguishing media**

**Suitable extinguishing agents:** CO<sub>2</sub>, powder or water spray. Fight larger fires with water spray or alcohol resistant foam.

### 6 – ACCIDENTAL RELEASE MEASURES

**Environmental precautions:** Do not allow to enter sewers/ surface or ground water. Inform appropriate authorities in case of leakage into water course or sewage system.

**Methods and material for containment and cleaning up:** Dispose of contaminated material as waste according to item 13. Ensure adequate ventilation. Soak up with inert absorbent material and dispose of as hazardous waste. Keep in suitable, closed containers for disposal.

**Personal protective equipment:** Keep away from foodstuffs, beverages and feed.

Immediately remove all soiled and contaminated clothing. Wash hands before breaks and at the end of work.

### **Hand protection:**

Suitable chemical resistant safety gloves. For example, nitrile rubber (0.4 mm), chloroprene rubber (0.5 mm), butyl rubber (0.7 mm). Dispose of used gloves in accordance with applicable regulations. The selected protective gloves need to satisfy the specifications of EU directive 89/686/EEC and the standard EN374 derived from it.
